Family Treatment Court Grant

The Callaway County Commission met with Cindy Garrett, Boone County Deputy Court Administrator; Mary Epping, Boone County Court Administrator; Judge Sue Crane; Karen Rentschler, Callaway County Auditor; Casey Clevenger, Boone County???; Megan Morse, Callaway County Circuit Clerk; and other Boone County Circuit Court representatives to discuss the Callaway Family Treatment Court Grant Funding. There was no representative from the Callaway County Clerk's office for this meeting.

Cindy Garrett explained Callaway County and Boone County have received a five year SAMHSA grant for the Callaway Family Treatment Drug Court from the Missouri Department of Health and Human Services Substance Abuse and Mental Health Services Administration.

Grant number 1H79TI081942-01, FAIN number H79TIO81942 was awarded on 05/31/2019 and allows the Callaway County Family Treatment Court to expand the program to 35 participants and allows participants to be eligible with only a dependency court case through the Juvenile Court.

The grant will cover for the following:

- 1) Salary & Benefits of Service Coordinator (\$37,548 salary; \$13,413.13 benefits)
- 2) Training: Service Coordinator and Project Director to attend required grant meeting in Washington, D.C.; 3 FTC members (CD, JO, SC) plus 2 contract providers to attend state MA TCP (March, 2020); 3 FTC members (CD, JO, SC) plus 2 contract providers to attend NADCP in July 14-17, 2019 in National Harbor, MD. (\$20,816).
- 3) Mileage of Service Coordinator to attend local meetings & project activities (\$800).
- 4) Laptop computer, printer, 2 monitors, keyboard & mouse (\$1,995).
- 5) MRT books for 25 participants (\$625).
- 6) Out-patient and in-patient treatment services with Compass Health and Reality House (\$58,800 for Out-patient; \$9,984 for in-patient).
- 7) Transportation with SERVE (\$40,560).
- 8) Drug Testing with Redwood (\$36,000).
- 9) Home Detention with Corrisoft (\$13,500).
- 10) Supervised Visitation with ???(maybe consider working with Family Facets who provides the Supervised Visitation program in Boone County) (\$59,800).
- 11) MAT through Reality House (\$54,000).
- 12) Peer Support Recovery Mentor with Compass Health & Reality House (\$22,800).
- 13) Recovery Housing with Local Landlords (\$50,000).

County pays funds up front and they are then reimbursed through SAMHSA through the HHS Payment Management System (PMS). Process has begun to set up account and all information will be sent to Karen Rentschler, Callaway County Auditor.

Presiding Commissioner Gary Jungermann gave an update on sales and use tax status and gave an update on the status of the potential capital project.

Eastern District Commissioner Randy Kleindienst explained the Commission is talking about a sales tax of close to 50% of collected sales tax is earned from outside residents.

Presiding Commissioner Gary Jungermann explained the tax would help county law enforcement and the court system. The average person would pay roughly \$40.00 more per year if the two sales taxes are passed.

Sheriff Clay Chism explained when the Sheriff office is full staff, which it never is, there are only 16 deputies to man the county 24/7/365. Most nights there are only two deputies to cover the whole county.

Commissioner Jungermann stated the Commission has looked at different options for a new court system and they have put a contract on the old Par 5 property at 213 Market Street and they are in talks with the Mattress Store on the connecting property at 4 East 3rd Street.
