## **APRIL 5, 2022 GENERAL MUNICIPAL ELECTION**

### **CANDIDATE FILING – Date, Time & Location**

- Candidate Filing Opens: December 7, 2021 at 8:00 a.m. **RSMo 115.127.5**
- Candidate Filing Closes: December 28, 2021 at 5:00 p.m. **RSMo 115.127.5**
- Location: Specific Political Subdivisions

### **BALLOT PLACEMENT**

- Generally with first day filing, a random drawing is done to determine ballot placement for the ballot. However, check with your Specific Political Subdivision to confirm the process.
- After the first day to file, candidates will be placed on the ballot in the order of their filing.

### **MUST FILE IN PERSON EXCEPTIONS**

- Candidates for office must file in person with the Specific Political Subdivision except for members of the armed services on active duty and disabled persons who may file by certified mail.  
**RSMo 115.355.2**

### **DOCUMENTS NEEDED FOR FILING**

- Missouri Driver's License, Voter I.D. Card, Birth Certificate or other form of identification are required at time of filing. **RSMo 115.355.4**
- Check with your Specific Political Subdivision to determine if there are additional requirements according to their by-laws.

### **FORM 5120 REQUIRED**

- Each candidate is required to submit a copy of "Candidate's Affidavit of Tax Payments and Bonding Requirements - Form 5120" **RSMo 115.306**

### **CANDIDATE WITHDRAWAL DEADLINES**

- A candidate may withdraw from the ballot without a court order until the 11th Tuesday prior to the election – January 26, 2021. **RSMo 115.127.6**
- A candidate may withdraw from the ballot with a court order until the 8th Tuesday prior to the election (may be responsible for incurred costs) – February 8, 2021. **RSMo 115.127.6**

### **ADDITIONAL ELECTION INFORMATION**

- First day for Absentee Voting – February 22, 2022 6th Tuesday prior to the election
- Last day to Register to Vote – March 9, 2022 4th Wednesday prior to the election
