The fees will range from \$100.00 to \$150.00 depending on the risk category the establishment falls into. Temporary food establishments will be increased to \$75.00 for 15-100 days in a calendar year, this does not include one-time events. State requires a commissary agreement with a place that has a kitchen that can be inspected. Temporary/one-time events permits will be available for purchase annually at \$30.00 for events that last no more than 14 days and a commissary agreement will not be required.

Lodging inspections will increase to \$200.00, the food handlers' requirements will stay the same but the Health Department will add a recommendation that one person with a food handlers' card be present during the duration of the event. Farmer's Market will not require a permit for whole uncut fruits/vegetables, however if the fruits/vegetables are cut/altered a permit will be required. Baked goods are exempt unless the baked goods need to be chilled.

The Health Department would like to recommend hair restraints and would recommend long hair and beard guards for all food employees.


The Health Department will remove the MODESE vs Non-MODESE and all schools will not be treated equally.
