The Callaway County Commission met with elects and supervisors for a quarterly update. In attendance at this meeting were: Andrea Bedrosian, Callaway County Health Department Administrator; Brenda Sondgeroth, Callaway County Building & Grounds; Clay Chism, Callaway County Sheriff; Chris Wilson, Callaway County Prosecuting Attorney; Debbie Zerr, Callaway County Treasurer; Darryl Maylee, Callaway County Sheriff's Office; Jody Paschal, Callaway County Assessor; Karen Digh Allen, Callaway County Public Administrator; Mitch Fletcher, Callaway County Road, and Bridge Supervisor; Paul Winkelmann, Callaway County Road, and Bridge Engineer; Rylee Page, Callaway County Auditor; Wes Bond, Callaway County IT Director; and Ronda Miller, Callaway County Clerk.

Rylee Page, Callaway County Auditor stated her office is working on the county budget and reminds everyone to turn in their budget paperwork.

Mitch Fletcher, Callaway County Road, and Bridge Supervisor, and Paul Winkelmann, Callaway County Road, and Bridge Engineer stated they are short two drivers, business is running, as usual, working on a paver and pugging processes. They are also working on preparing for winter weather and in the process of getting a new grader.

Wes Bond, Callaway County IT Director stated he is working on the phone system at the Sherriff's Office/Jail and working on switching the Sheriff's office/jail to Callabyte, along with dealing with other issues in the county.

Clay Chism, Callaway County Sheriff, and Darryl Maylee, Callaway County Sheriff's Office stated they are in a staffing crisis at the Sheriff's Office and at the Jail. If anyone wants a tour of the new facility they should allow for one hour and can contact him or Darryl to make arrangements.

Andrea Bedrosian, Callaway County Health Department Administrator stated the Health Department has flu shots in, and they are currently working on offering HIV/STD testing. The employee health fair was a success.

Ronda Miller, Callaway County Clerk stated her office is working on the election.

Brenda Sondgeroth, Callaway County Building & Grounds stated her department is preparing for winter.

Chris Wilson, Callaway County Prosecuting Attorney stated his office is busy, they have a new attorney starting November first, a new legal intern recently started, a new victim advocate recently started and they are currently looking for another paralegal.

Karen Digh Allen, Callaway County Public Administrator explained the type of individuals her office serves, discussed her and her staff's caseloads, and stated she is working with various groups to find a solution to the mental health crisis.

Debbie Zerr, Callaway County Treasurer stated interest rates are going well and explained the interest rate tiers to the group.

Eastern District Commissioner Randy Kleindienst stated he is proud of the county staff and how they have been serving the citizens of the county.
