#### **New Term of Court**

The Callaway County Commission met with Paul Winkelmann, Callaway County Road and Bridge Engineer to discuss a new term of court. Jennifer Delashmutt, Callaway County Citizen was also present at this meeting. A representative from the Callaway County clerk's office was present for this meeting.

Paul Winkelmann, Callaway County Road and Bridge Engineer stated there are no new road vacation or NID's, and they have a stockpile of rock.

Jennifer Delashmutt stated she is concerned about how CR 328 will be affected by the State of Missouri's upcoming projects on Rte. J. Mrs. Delashmutt stated she is aware MODOT wont use CR328 as a detour route but she also is aware that citizens who are familiar with the area will use the road instead of taking the MODOT detour and she is concerned about the bridges being able to handle the extra weight and the width of the road. Paul Winkelmann stated Road and Bridge would do a traffic count on CR328 before the State begins work and Eastern District Commissioner Randy Kleindienst stated Road and Bridge will add more speed signs to the road but added they cannot make people obey the traffic laws. Presiding Commissioner Gary Jungermann stated the county will work with MODOT as much as possible.
