Pat Stemme Meeting

1:15 p.m.

Eastern District Commissioner Randy Kleindienst, and Western District Commissioner Roger Fischer met with Pat Stemme to discuss solar, Grain Belt Express and wind power. There was no representative from the County Clerk's office for this meeting.

Pat Stemme stated she wants to know the Commission's position regarding the Grain Belt Express.

Eastern District Commissioner Randy Kleindienst stated he thinks it's ridiculous if the Grain Belt Express will cut farms in half, he is not sure where the Grain Belt Express plans to go or whether it is needed.

Western District Commissioner Roger Fischer stated he agrees with Eastern District Commissioner Randy Kleindienst's stance regarding people's property and believes property values could be going up.

Pat Stemme stated she believes green energy will ruin our county and she has the right to look out her window and "not see something unsightly". She believes it's "evil" that neighbors have signed with solar and are putting solar farms near neighbor's property and not near their own homes "ruining our countryside so St. Louis can have energy."

Ms. Stemme also stated this energy will cause blackouts like in California and suggests the Commission "keep your enemy close" and suggest they have discussions with the energy companies to lean as much as they can, however don't believe what they say because they are all liars.

Ms. Stemme states the owner of Invenenergy "came here from Ukraine" and got funding from Bill Clinton and George Soros and now is a billionaire, this is just the elite trying to make more money.

Western District Commissioner Roger Fischer stated he agrees with many of the issues Pat Stemme has brought up and says people are "drinking the Kool-Aid" regarding green energy.

Eastern District Commissioner Randy Kleindienst stated his biggest concern is personal property rights and there is a fine line about property infringement: "I may not like it if my neighbor paints their house orange, but it's not really infringing on my rights."

Pat Stemme asked "do solar companies have to get permission to start building?"

Eastern District Commissioner Randy Kleindienst replied "no."

Pat Stemme then stated "so then your opinion doesn't really matter then, does it?"

Eastern District Commissioner Randy Kleindienst stated "the only restrictions we have are dealing with county roads." and he advised Pat Stemme to contact State Legislators about her concerns as County Commission cannot do anything about it.

Committee members in attendance at this meeting were Tamara Tateosian, Callaway Chamber of Commerce; Jo Belmont, City of Mokane; Rylee Page, Callaway County Auditor; Jeanna Machon, Callaway County Grants Administrator; Michelle Kidwell, Callaway County Emergency Management Director; Andrea Bedrosian, Callaway County Health Department Administrator; Brandon Ruediger, City of Holts Summit and Missy Hooks, City of Auxvasse. Rene Tyler, City of Fulton City Administrator and Courtney Doyle, City of Fulton were also present at this meeting.

Jo Belmont began the meeting by announcing the City of Mokane would be withdrawing their application.

Jeanna Machon presented the group a breakdown of the funding and the group discussed the information.

Presiding Commissioner Gary Jungermann reminded the group they have until December 2024 as long as there is a contract and announced the Be Proud Be Pro simulator would be arriving in Callaway County the week of March 20th.

Tamara Tateosian stated there would be a breakfast at Callaway Electric March 20th at 8:00 a.m. with a ribbon cutting following the breakfast for the Be Proud Be Pro arrival.

Presiding Commissioner Gary Jungermann discussed the city of Mokane CDBG grant and stated the urgent care is still in process.

Brandon Ruediger stated he would like to revisit the CAD system discussion.

Presiding Commissioner Gary Jungermann stated he would prefer to have a separate meeting to discuss the CAD system.

Jeanna Machon stated Day Solution's application is still on hold.

Tamara Tateosian stated the building has already been renovated and suggested a bus for Day Solutions.

Presiding Commissioner Gary Jungermann stated the Holt Summit ramps are still a MODOT issue, and the Callaway Fire rural fire CAD systems are also on hold until other CAD issues are resolved.

The group chose to skip over the YMCA pool, the SERVE status is unclear and then the group discuss the City of Fulton fire truck application in the amount of \$500,000.00.

Rene Tyler, City of Fulton City Administrator stated the City assistance with calls have increased drastically and the wear and tear from the county roads on the city fire trucks are hard on the trucks. She would appreciate any amount of funds if the half a million is not available.

Presiding Commissioner Gary Jungermann stated the Country Club has applied for remodeling and the Callaway Youth Expo has presented an application in the amount of \$200,000.00 for a new building to be used for concessions and as a community center. Jeanna Machon suggested the Youth Expo apply for and use the Safe Room fund toward their building and make the community center into a safe room for tornados.

Missy Hooks stated their sewer project bids came in alot higher than anticipated.

Presiding Commissioner Gary Jungermann stated the floor is open to general conversation.

Jo Belmont stated may the fire truck is more important to the community as a whole than the YMCA or Country club.

Brandon Ruediger stated mobile CAD also touches the entire community.

Jo Belmont asked if the group would be willing to remove any of the applications from the list?

Missy Hooks stated it bothers her that the committee would even look at a business such as Day Solutions or the Country Club.

Presiding Commissioner Gary Jungermann asked how many would be in favor of eliminating Day Solutions, YMCA and the Country Club's applications? The group voted to eliminate all of the applications.

Jeanna Machon stated she would send out the newest applications to the committee members.

Eastern District Commissioner Randy Kleindienst asked how the 4-H Youth Expo group was any different than the YMCA?

Tamara Tateosian asked if the 4-H Youth Expo group would be charging citizens and/or making a profit? If they are she believes they are no different than the YMCA.

Missy Hooks states the City of Auxvasse already has a brand-new community center on Main Street.

Michell Kidwell stated she would be in favor if 4-H could work with the City of Auxvasse to make their center work for the benefit of everyone in the City.

Rene Tyler reminded the group that the City's fire trucks have been the first on the scene for fire calls around the county.

Eastern District Commissioner Randy Kleindienst asked Rene Tyler if the City of Fulton received any ARPA fund.

Rene Tyler stated the City of Fulton did receive separate ARPA funds and they are putting some of the funds toward the truck but are also applying for other grants.

The group engaged in open discussion regarding the fire fighter issues in the county.

Presiding Commissioner Gary Jungermann stated he would like someone else to organize the CAD discussion and the group would need to know the cost, options and thoughts of everyone who used the CAD/EMS systems.
