Presiding Commissioner Gary Jungermann opened the meeting, stated no decisions would be made at the meeting, requested all comments from the citizens be held until the Commission calls on them, and requested anyone speaking please speak loud enough for everyone in the back of the room to hear.

Benjamin Miller gave a speech about why he feels the phrase "The Kingdom of Callaway" should not be associated with the Callaway County Justice Center.

Bob Sterner gave a speech about why he feels the phrase "The Kingdom of Callaway" should not be associated with the Callaway County Justice Center.

Casey Clevenger gave a speech about why he feels the phrase "The Kingdom of Callaway" should not be associated with the Callaway County Justice Center.

Alan Combs – Gave a speech about why the phrase should be removed.


