2023 Regional Bridge Program

Howe Company is working on this project and the June update showed the current activities as environmental permitting and cultural resource survey. The next activities listed as coming up are easement documents, right-of-way acquisition, and final construction plans. It is anticipated that this project will be completed and bid in the first quarter of 2025.

CR 419 Creek Crossing – A contract has been executed with Widel Construction for \$596, 113.75. The NTP was issued on May 28, 2024, and construction has been started. The Contractor has completed the drilling for all the drilled shafts and the concrete pour for them is scheduled for Tuesday and Wednesday of next week. The anticipated completion date is mid-late September 2024.

An amendment to the consultant agreement was executed with Howe Company to provide construction management and inspection services for the project.

CR 445 Bridge @Kemps – A contract has been executed with Widel Construction for \$488,801.80. The NTP was issued on June 5, 2024, but it is anticipated that construction on site will not start until the week of August 12, 2024, after the completion of the major work on the bridge on CR 419.

This bridge has been funded with BRO dollars and Howe Company is to provide construction management and inspection services for the project.

2024 Regional Bridge Program – The deadline to submit a project for BRO funding is October 1, 2024 - November 12, 2024. I also need to identify a prioritized list of bridges to be submitted for BEAP studies.

Howe Company is working on this project and the June update showed the current activities as environmental permitting and cultural resource survey. The next activities listed as coming up are easement documents, right-of-way acquisition, and final construction plans. It is anticipated that this project will be completed and bid in the first quarter of 2025.

BASE One & Hill Projects – We still need to discuss and finalize which BASE ONE pug projects we want to complete in 2024. I still need to develop a bid package to bid the purchase of the product for this year.

CR 230 Aluminum Box Culvert – As per the last report, the property Owner to the south – Tom Dawson has signed the easement documents. Since the last meeting, a meeting was held onsite with the Callaway County Commission, Todd Castle, his son, and me to discuss possible options for proceeding with the planned work. I need to review the project and revise the previous documents based on the onsite discussions and then schedule another meeting to review and discuss the signing of the required easement documents with Todd Castle.

Chip Seals 2024 – We have a signed contract with Missouri Petroleum Products Company for \$372,536.57 for chip seal maintenance work at all the nine (9) sites that were bid this year. I have requested a proposed construction schedule from the Contractor but have not received it to date. The NTP for the work will be issued after the Contractor's construction schedule is approved.

Highway Entrance Asphalt Construction 2024 – I am finalizing the bid package for this work for a proposed 11 entrance locations. The current estimate for the proposed work is approximately \$250,000 for a proposed nine (9) sites (CR 452/SR TT, CR 470/SR PP, CR 477/SR O, CR 110/ US 54, CR 209/US 54, CR 328/ US 54, CR 328/SR J, CR 338/US 54, and CR 338/SR J). I should have the bid package ready this week. The proposed bid date and completion date for the work needs to be discussed and finalized.

Overlays 2024 - The chip seal work and the proposed highway entrance asphalt construction will use up all the 2024 Asphalt Maintenance budget. I will review the asphalt condition ratings and develop a proposed list of overlay work to plan for the next calendar year. After the list is developed, I will start working on the bid package so that it is ready to bid early in 2025. Please let me know if there are any that you propose for inclusion.

CR 133 Hill Paving Project - Same report as last meeting, plans were completed last fall but only had one bidder. The bid was not awarded. I need to review this bid package to see what it would take to rebid the project.

Cinders & Salt – Had a light year for usage so the amount bid this year was 50 tons less. No new deliveries to date.

CR 326 Aluminum Box Culvert – Same report as last meeting, we have a small bridge (less than 20' span) that has some issues with the abutment settling and undermining that can be replaced with an aluminum box culvert. Just need to get maintenance work agreements with the property owners, a COE permit, and bid a box. County crews will construct this project.

MDC Rock 2024 –The County was fully reimbursed for the 2024 MDC CART rock. We will be working on the new agreements for 2025 in the next term.

Dust Control 2024 – The dust control work has been completed in areas 2 and 3 and Area 4 is about 80% complete. The applicator has told me that he will be completing all the remaining dust control work in the county this week. He told me that he will have two spray rigs working today with one finishing up Area 4 and one starting on Area 1, and then both working on Area 1 once Area 4 has been completed.

In 2024, the LAGERS budget was set at \$847,713.57. However, with the introduction of the new LAGERS benefit level six, it is projected that the budgeted amount for LAGERS will increase to approximately \$1,464,698.25 for

2025. Alternatively, if the county opts for the LAGERS benefit level eight, the estimated budgeted amount for LAGERS is expected to be around \$983,667.25 for the same year.

Leah Laramore indicated that Callaway County has not modified the LAGERS benefit program in the past, and any alterations proposed this year would impact all full-time employees. If approved, the LAGERS notice must be displayed on the Callaway County website for 45 days and would become effective on the first day of the month following this period.

Sheriff Darryl Maylee was also present for this meeting. A representative from the Callaway County Clerk's office was in attendance at this meeting.

Leah Laramore presented a spreadsheet created by Rylee Page, Callaway County Auditor showing projected estimates for five years at the current LAGERS rate and with the increased LAGERS rate.

Presiding Commissioner Gary Jungermann reminded the group that any raises/salary increases would affect the numbers presented.

Darry! Maylee voiced concerns regarding the impact of the LAGERS increase on the Sheriff's office, highlighting that such a change would significantly consume a large portion of the office's budget, which is funded by the Proposition One sales tax. He argued that this would eventually lead to the complete depletion of these funds. To illustrate his point, he cited the Boone County Sheriff's Office as an example of a law enforcement group currently facing similar challenges.

Leah Laramore stated if the change is approved, it will start after 45 days of public notice. Employees will still need to work with the County for 5 years to get full benefits. The group talked about the good and bad points of changing the LAGERS plan.

Western District Commissioner Roger Fischer made a motion to approve increasing the LAGERS benefit from the L7 program to the L6 program which will increase the multiplier from 1.5% to 2%, and authorize Presiding Commissioner Gary Jungermann and/or Leah Laramore, Callaway County Human Resource Director to sign on behalf of the county.
