



Eastern District Commissioner Randy Kleindienst seconded the motion. Motion carries, court order 104 was signed.



Way Brondel wants the Department of Corrections building turned into a homeless shelter, wants a Callaway County lawyer who does work for the citizens of Callaway County and wants a letter on county letterhead saying he was here in a meeting with the Commission on November 07, 2024.


